

**NEW ERA CAP 2009 MLB CALL-UP SWEEPSTAKES
OFFICIAL RULES**

NO PURCHASE IS NECESSARY TO ENTER OR WIN. PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

By taking part in the New Era Cap 2009 MLB Call-Up Sweepstakes you accept and agree to be bound by these Official Rules and agree that all decisions of the Sponsors are final and binding. These Official Rules apply only to this Sweepstakes and not to any other promotions, contests, or sweepstakes sponsored by New Era Cap Co., Inc.

SPONSORS: This Sweepstakes is sponsored by the New Era Cap Co., Inc. 160 Delaware Ave., Buffalo, NY 14202 ("**New Era Cap**") and Chicago National League Baseball Club L.L.C. d/b/a The Chicago Cubs ("**Chicago Cubs**") (collectively "**Sponsors**").

SWEEPSTAKES PERIOD 1: "NEW ERA CAP 2009 MLB CALL-UP SWEEPSTAKES" (the "**Sweepstakes**") **Period 1** begins at 9 AM Eastern Standard Time on April 1, 2009 and ends at 11:59 PM Eastern Standard Time on April 30, 2009 ("**Sweepstakes Period 1**").

SWEEPSTAKES PERIOD 2: The **Sweepstakes Period 2** begins at 9 AM Eastern Standard Time on May 1, 2009 and ends at 11:59 PM Eastern Standard Time on May 31, 2009 ("**Sweepstakes Period 2**").

ELIGIBILITY, RESIDENCY AND AGE: The Sweepstakes is open only to legal residents of the United States, including the District of Columbia who are eighteen (18) years of age or older as of the date of entry. Employees, officers, representatives or agents of Sponsors, Major League Baseball ("MLB"), Major League Baseball Advance Media ("MLBAM"), eFashion Solutions, or any Major League Baseball Team ("MLB Team"), their affiliated entities, and their immediate family members (spouse, parents, siblings, children, in-laws, grandparents, grandchildren) and each of their respective parent companies, subsidiaries, affiliates, agents and their advertising agencies, sweepstakes agencies and production agencies are not eligible to enter. NOTIFICATION TO WINNERS:

Sweepstakes Period 1: Winner 1 will be notified by **Friday, May 8, 2009** by telephone using the cellular number by which the entry was made and/or as provided on the mail in entry form.

Sweepstakes Period 2: Winner 2 will be notified by **Monday, June 8, 2009** by telephone using the cellular number by which the entry was made and/or as provided on the mail in entry form.

Winner 1, Winner 2 and each guest will be required to execute and return to the Sponsors an Affidavit of Eligibility/Liability and a Publicity Release via overnight courier in order to claim the prize. No arrangements will be scheduled without executed Affidavits.
