

**“NEW ERA CAP ATLANTA FLAGSHIP STORE BASEBALL SWEEPSTAKES”
OFFICIAL RULES**

NO PURCHASE IS NECESSARY TO ENTER OR WIN. PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

By taking part in the New Era Cap Atlanta Flagship Store Baseball Sweepstakes you accept and agree to be bound by these Official Rules and agree that all decisions of Sponsor are final and binding. These Official Rules apply only to this Sweepstakes and not to any other promotions, contests, or sweepstakes sponsored by New Era Cap Co., Inc.

SPONSOR: This Sweepstakes is sponsored by the New Era Cap Co., Inc., 160 Delaware Ave., Buffalo, NY 14202 (“New Era Cap” or “Sponsor”).

SWEEPSTAKES PERIOD: “NEW ERA CAP ATLANTA FLAGSHIP STORE BASEBALL SWEEPSTAKES” (the “**Sweepstakes**”) begins at 9 AM Eastern Standard Time on September 23, 2009 and ends at 1:00 PM Eastern Standard Time on September 30, 2009 (the “**Sweepstakes Period**”).

ELIGIBILITY, RESIDENCY AND AGE: The Sweepstakes is open only to legal residents of the United States (excluding U.S. Virgin Islands, Puerto Rico, and U.S. military bases outside the U.S.) who are twenty (21) years of age or older as of the date of entry. Employees, officers, representatives or agents of New Era Cap, Vibes Media, and eFashion Solutions and affiliated entities, and their immediate family members (spouse, parents, siblings, children, in-laws, grandparents, grandchildren) and each of their respective parent companies, subsidiaries, affiliates, agents and their advertising agencies, sweepstakes agencies and production agencies are not eligible to enter. This Sweepstakes is subject to all federal, state and local laws and regulations. HOW TO ENTER: Send your entry via text message or by visiting the website as described below. Limit of one entry per person regardless of method of entry. All entrants must have a text messaging two-way capable handset and digital service in order to enter the Sweepstakes using the text messaging method. Sponsor is not responsible for lost, late, incomplete, illegible, mutilated, invalid, unintelligible, or misdirected entries; all such entries will be disqualified. To enter using text messaging: During the Sweepstakes Period, using your own text-messaging capable phone, send a text message with the word “BRAVES” from your handset addressed to shortcode 639372. Once you send the text message, you will be automatically entered into the Sweepstakes. Entry into the sweepstakes automatically subscribes the registrant to the New Era Alert system. You will be charged for all text messages sent and received from your handset according to the terms in your individual Calling Plan with your cellular provider. All entries must be received no later than 1:00 PM Eastern Standard Time on

September 30, 2009. Text messaging service is not available in all areas. **LIMIT ONE ENTRY PER PERSON REGARDLESS OF METHOD.**

To enter without using text messaging or to enter for free: During the Sweepstakes Period, visit www.neweracap.com/contests or www.neweracap.com and see the "Contests" section under "About Us" and complete and mail the entry form. All information on the entry form must be complete for the entry to be accepted. Incomplete or illegible entries will be disqualified. All entries must be received by 1:00 PM Eastern Standard Time on September 30, 2009. **LIMIT ONE ENTRY PER PERSON REGARDLESS OF METHOD.**

PRIZE: One (1) winner will receive two (2) tickets to the Atlanta Braves versus the Washington Nationals (the "**Game**") starting at 7:30 p.m. Eastern Standard Time on Friday, October 2, 2009 at Turner Field located at 755 Hank Aaron Drive, Atlanta, GA 30315. The odds of winning depend on the number of eligible entries received. The Winner is responsible for their transportation to and from Atlanta, to and from the "Game" and is also responsible for any and all other expenses related to their acceptance of any prize. The Winner is also responsible for all federal, state and local taxes, including completion of W-9 taxation forms.

RANDOM DRAWING: One (1) winner will be selected in a random electronic drawing at 2:00 PM Eastern Standard Time on September 30, 2009.

NOTIFICATION TO WINNERS: The winner, regardless of entry method, will be notified by phone within 24 hours of the random drawing. If the Winner does not answer, and a message machine is available, a voice mail message will be left and the Winner must return the call within 24 hours. If the Winner cannot be reached because the (a) Sponsor does not reach the Winner personally, (b) Sponsor is unable to leave a winning voice mail message notification, (c) the potential winner does not return the phone call to the Sponsor OR (d) in the event a potential winner does not accept the prize or fails to comply with these rules and requirements, the prize will be forfeited. Upon prize forfeiture, no compensation will be given. Will Call opens three (3) hours prior to all home games and closes at the end of the 6th inning. Will Call is then moved to the receptionist desk inside of the 755 Club until the end of the game.

Individuals who fail to present a valid photo ID will be denied redemption of the prize.
