

**“NEW ERA CAP PRE-DRAFT PARTY WITH BLAKE GRIFFIN SWEEPSTAKES”  
OFFICIAL RULES**

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.**

By taking part in the New Era Cap Pre-Draft Party with Blake Griffin Sweepstakes you accept and agree to be bound by these Official Rules and agree that all decisions of Sponsor are final and binding. These Official Rules apply only to this Sweepstakes and not to any other promotions, contests, or sweepstakes sponsored by New Era Cap.

**SPONSOR:** This Sweepstakes is sponsored by the New Era Cap Co., Inc. 160 Delaware Ave., Buffalo, NY 14202 (“New Era Cap” or “Sponsor”).

**SWEEPSTAKES PERIOD:** “NEW ERA CAP PRE-DRAFT PARTY WITH BLAKE GRIFFIN SWEEPSTAKES” (the “**Sweepstakes**”) begins at 9 AM Eastern Standard Time on June 17, 2009 and ends at 1:00 PM Eastern Standard Time on June 22, 2009 (the “**Sweepstakes Period**”).

**ELIGIBILITY, RESIDENCY AND AGE:** The Sweepstakes is open only to legal residents of the United States (excluding U.S. Virgin Islands, Puerto Rico, and U.S. military bases outside the U.S.) who are twenty (21) years of age or older as of the date of entry. Employees, officers, representatives or agents of New Era Cap, Vibes Media, and eFashion Solutions and affiliated entities, and their immediate family members (spouse, parents, siblings, children, in-laws, grandparents, grandchildren) and each of their respective parent companies, subsidiaries, affiliates, agents and their advertising agencies, sweepstakes agencies and production agencies are not eligible to enter. This Sweepstakes is subject to all federal, state and local laws and regulations. VOID in Puerto Rico, the U.S. Virgin Islands, U.S. Military installations in foreign countries, anywhere outside of the U.S. and VOID WHERE PROHIBITED, TAXED OR RESTRICTED BY LAW.

**HOW TO ENTER:** Send your entry via text message or by visiting the website as described below. Limit of one entry per person regardless of method of entry. All entrants must have a text messaging two-way capable handset and digital service in order to enter the Sweepstakes using the text messaging method. All entries become the sole property of the Sponsor and receipt of entries will not be acknowledged or returned. Sponsor is not responsible for lost, late, incomplete, illegible, mutilated, invalid, unintelligible, or misdirected entries; all such entries will be disqualified. No facsimiles, mechanical reproductions, alterations or forged entries are permitted.

**To enter using text messaging:** During the Sweepstakes Period, using your own text-messaging capable phone, send a text message with the word “BLAKE” from your handset addressed to shortcode 639372. Once you send the text message, you will be automatically entered into the Sweepstakes. Entry into contest also enters registrant into the New Era Alerts system. To be unsubscribed from New Era Alerts, text QUIT to 639372 at any time. You will be charged for all text messages sent and received from your handset according to the terms in your individual Calling Plan with your cellular provider. All entries must be received no later than

1:00 PM Eastern Standard Time on June 22, 2009. Text messaging service is not available in all areas.

**To enter without using text messaging or to enter for free:** During the Sweepstakes Period, visit [www.neweracap.com/contests](http://www.neweracap.com/contests) or [www.neweracap.com](http://www.neweracap.com) and see the "Contests" section under "About Us" and complete and mail the entry form. All information on the entry form must be complete for the entry to be accepted. Incomplete or illegible entries will be disqualified. All entries must be received by 1:00 PM Eastern Standard Time on June 22, 2009.

**PRIZES:** Twenty-five (25) winners will each get one (1) admission/entry for them and one (1) admission/entry for a guest to the New Era Cap Pre-Draft Party with Blake Griffin to be held from 7 p.m. Eastern Standard Time to 10 p.m. Eastern Standard Time on June 23, 2009 at the New Era New York City Flagship Store located at 9 East 4th Street, New York, New York 10003, 212-533-CAPS (2277). The odds of winning depends the number of eligible entries received. Winners are responsible for their transportation to and from New York City, to and from the New Era Cap Pre-Draft Party with Blake Griffin and are also responsible for any and all other expenses related to their acceptance of any prize. Winners are also responsible for all federal, state and local taxes, including completion of W-9 taxation forms.

**RANDOM DRAWING:** Twenty-five (25) winners will be selected in a random electronic drawing at 1:00 PM Eastern Standard Time on June 22, 2009.

**NOTIFICATION TO WINNERS:** Winners who entered via the text messaging method will be notified by text message within one hour/sixty minutes of the random drawing. Winners who entered via the online entry form will be notified by phone and/or email within one hour/sixty minutes of the random drawing. If a winner cannot be reached because (a) the winning text message notification is returned as undeliverable, (b) the winning email notification is returned undeliverable or (c) Sponsor is unable to leave a winning phone message notification OR in the event a potential winner does not accept the prize or fails to comply with these rules and requirements, the prize will be forfeited. Upon prize forfeiture, no compensation will be given. The prize is non-transferable; the prize cannot be substituted for another prize; the prize cannot be sold; and the prize cannot be redeemed for cash from Sponsor.
